

Function One UV Disco Hire Terms and Conditions and Hire Agreement

Please read the following points carefully and sign the document, Failure to agree will lead to the cancelation of your booking. It is the responsibility of the customer (hirer) to ensure that all possible steps are taken to avoid injury or damage to the venue.

Please ensure that the following safety instructions are followed:

- 1) Full payment must be made at the start or prior to your event as agreed in the booking conditions
- 2) Function One Entertainment take no responsibility for checking the chosen venue has the correct music licences for playing live music.
- **3)** There must be at least 2 power sockets within 20 metres of where the disco will be placed.
- **4)** Any threatening or antisocial behaviour towards ANY Function One Entertainment staff member will not be tolerated under any circumstances and could lead to the end of our services at the party or event.
- **5)** Function One Entertainment will ensure any incidents are followed up and Function One Entertainment will support its staff to prosecute those involved
- **6)** You must allow a minimum of 60 minutes for the set up of equipment.
 - You must allow a minimum of 60 minutes for packing equipment away unless otherwise agreed.
- 8) Function One Entertainment are not responsible for any charges to you by the venue due to not allowing our minimum set up or pack down times.
- **9)** Smoke and or flashing/strobe lights may be used at anytime during your disco unless you have stated otherwise.
- **10)** Any incidents or complaints involving Function One Entertainment or its staff must be sent in writing to us within working 7 days of the issue.

- **11)** Function One Entertainment can not take any responsibility for damage to a venue unless it is due to negligence of our staff.
- 12) Function One Entertainment can not take any responsibility for any injury or death of anyone at an event.13) Function One Entertainment take no responsibility for the darkness of any hall used for a UV disco or the effectiveness of the UV lighting.
- 14) UV Body paints are given to use at the start of the disco, it is the hirers responsibility to ensure no one is allergic or will have a reaction to the paint. Function One Entertainment take no responsibility for any allergic reactions. Body paints may stain clothing Function One Entertainment take no responsibility for damage to clothing.
- **15)** All power sources must be able to take a standard UK 3 prong plug, We do not carry any adapters for any other type of plug therefore you are responsible for ensuring this.
- **16)** Glow sticks and foam LED batons are given to all children and it is the hirers responsibility to monitor that children do not puncture or damage the glow sticks or batons and use them correctly.
- 17) The use of latex balloons is used at parties, if anyone has an allergy then Function One Entertainment must be notified to stop the use of balloons.
- 18) Electric or handheld confetti canons may be used during the disco at a random time if the venue is deemed appropriate, it is your responsibility to ensure the venue are happy for this and you are responsible for cleaning the confetti and disposing of it at the end of your party or event.
